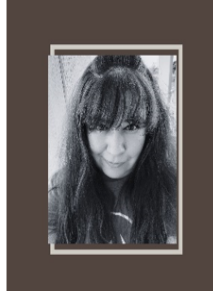


Figure 2 Christine Vanagas

12th Annual Sunday Supper for Jocelyn House Hospice

This Week's News

1. **Manitoba Government Introduces Legislation to Protect Workers Recovering from Illness or Injury**

The Manitoba government is amending the Employment Standards Code to extend unpaid long-term leave for serious illness or injury from 17 to 27 weeks, as announced by Labour and Immigration Minister Malaya Marcelino. This change aligns with federal employment insurance benefits, ensuring Manitoba workers don't have to choose between recovery and financial stability. The amendments follow federal changes to EI, enhancing sickness benefits and leave periods for federally regulated employees. <https://news.gov.mb.ca/news/index.html?item=62318&posted=2024-03-07>

2. **Measles Update**

Manitoba Health officials are emphasizing the importance of staying current with vaccinations to prevent measles, as cases rise globally and in other parts of Canada. No recent cases have been reported in Manitoba since 2019, and the province recommends vaccinations for children at 12 months and between ages four and six. Public health is actively monitoring the situation, providing information to health-care providers, and investigating reported cases to protect public health. <https://news.gov.mb.ca/news/index.html?item=62377&posted=2024-03-08>

3. **"WHY WOULD I COME BACK?": Nurses aren't taking up gov't's plan to return to health care system**

The Manitoba government's initiative to encourage retired nurses to return to the healthcare system is facing resistance from former nurses. Despite the government's efforts to streamline the re-entry process, the Manitoba Nurses Union reports negative feedback, citing concerns over workplace safety, mandatory overtime, and overwhelming workloads. Health Minister Uzoma Asagwara acknowledges these challenges and commits to improving the healthcare work environment and culture. <https://winnipegsun.com/news/provincial/why-would-i-come-back-nurses-arent-taking-up-govts-plan-to-return-to-health-care-system>

4. **Manitobans should get up to date on measles vaccinations before travelling, province says**

Manitoba's chief public health officer, Dr. Brent Roussin, urges residents to ensure their measles vaccinations are up-to-date before international travel, given the global rise in measles cases. While Manitoba hasn't confirmed any measles cases, the disease remains highly infectious and serious, particularly for those born after 1970 who may lack immunity. The province recommends that travellers visit their doctor or a travel clinic well in advance of their trip for vaccination advice. <https://www.cbc.ca/news/canada/manitoba/manitoba-measles-update-travel-1.7139234>

5. **Manitoba Government Introduces Legislation to Protect Workers Recovering from Illness or Injury**

The Manitoba government is amending the Employment Standards Code to extend unpaid long-term leave for serious illness or injury to 27 weeks, aligning with the revised federal employment insurance benefits. Announced by Labour and Immigration Minister Malaya Marcelino, this change aims to provide Manitoba workers the necessary time for treatment and recovery without the financial burden of choosing between health and livelihood. <https://news.gov.mb.ca/news/index.html?item=62318&posted=2024-03-07>

6. **Time to invest in team-based care and the training for health professionals who provide it: Team Primary Care Summit**

The Team Primary Care Summit in Ottawa brought together health professionals, educators, and leaders to urge government investment in team-based care and professional training. Highlighting the need for interprofessional collaboration, the Summit stressed transforming primary care training and practice. Drs. Ivy Oandasan and Ivy Lynn Bourgeault emphasized the urgency of moving away from siloed care to collaborative models, underscoring the importance of comprehensive, integrated care for a more sustainable healthcare system.

7. **Can you apply for Canada's dental plan? Eligibility rules get update**

Health Canada has updated eligibility rules for the Canadian Dental Care Plan (CDCP), now open to seniors 70 and older, and soon to those aged 65 to 69. Eligibility criteria include lacking existing dental insurance, a family net income below \$90,000, and recent tax filing. Those with employer or organizational dental insurance are ineligible, but opting out of pension benefits with dental coverage could grant eligibility. Over a million seniors have been approved so far, with the plan set to expand to more groups, including disabled adults and children under 18.

8. **Health minister 'deeply concerned' about rise of measles cases in Canada**

Health Minister Mark Holland expresses deep concern about the increasing cases of measles in Canada, particularly in Ontario, Quebec, and British Columbia. This resurgence is attributed to vaccine hesitancy and a decline in vaccination rates. The Public Health Agency of Canada (PHAC) stresses the importance of staying up-to-date with measles vaccinations to prevent the spread of this highly contagious disease.

9. **Manitoba Government Introduces Proposed Legislation that would Make Workplaces Safer**

The Manitoba government is introducing Bill 17, a proposed legislation aimed at enhancing workplace safety and health protections. Announced by Labour and Immigration Minister Malaya Marcelino, this bill focuses on reinstating the Advisory Council on Workplace Safety and Health, which was previously repealed in 2018. The council, comprising representatives from various sectors, will advise on occupational health and safety issues and potential legislative changes.

10. **Mental health commission developing audit program around psychological safety at work**

The Mental Health Commission of Canada (MHCC) is developing a Psychological Health and Safety Audit Program with a \$820,000 investment from Employment and Social Development Canada. This initiative, led by MHCC's Opening Minds, will provide evidence-based training for auditors, certify them, and pilot the program with employers to promote psychological health and safety in workplaces. The program aims to create psychologically safer workplaces, more engaged workforces, and healthier communities.
